63/22	Public Question Time	
	There was two members of the public present. David Johns attended the meeting (in his words) to draw attention to the uproar among Priorslee residents regarding the planning application TWC/2021/0871 for the extension of the Holy Trinity Academy and the handing over and fencing off of what is currently freely accessible public green space – the public playing fields adjacent to the school. He outlined the reasons for the residents' objections. He asked the parish council to object to the planning application and to open a discussion between the residents, Telford & Wrekin Council and the school to see if a more acceptable solution could be found. Ian Askey also presented objections to the proposed installation of fencing around the field adjacent to the school. He said that the land was given to community, with conditions and that it has been a freely available green space for the past 30 years.

	 Cllr I Fletcher declared an interest because of his position on the Borough Council Planning Committee and said that he would take no part in discussions about planning matters. Cllr Mrs V Fletcher declared an interest as a substitute member of the Borough Council Planning Committee and reserved her right to speak and/or vote on planning matters. Cllr D Wright declared a non-pecuniary interest as Telford & Wrekin Cabinet Member with responsibility for housing and infrastructure and said that he would not take part in any discussions about strategic planning matters. 	

 Cllr R Overton declared an interest in Agenda Item 6(a) (Planning Applications for July and August 2021) regarding planning application TWC/2021/0871 since as a Borough Councillor he had voted for the expansion of the school.

Members agreed that they would make any other declarations if they arose during the meeting.

Resolved: that the minutes of the Parish Council Meeting held on 20th July 2021, having been circulated, be agreed and signed by the Chairman as a true record subject to amendments to Minute 49/22 to state that there is a lack of seats for walkers in the parish (not just Priorslee) and that an audit will be carried out of existing benches in St Georges and Priorslee, to propose new locations and to research options for new benches.

Following a discussion about the proposals, it was

Resolved by a majority: to object to the planning application for the following reasons:

- Firstly, because of the proposed installation of fencing around the grass pitches outside the present school boundary, given that this green space was gifted to the community in 1991 for recreational use by local residents.
- Secondly, because the proposed installation of 15m high floodlights will cause light pollution and use of the 3G pitch in the evenings, may cause noise disturbance to local residents.
- Thirdly, the expansion of the school will result in more traffic in a residential area that is already adversely impacted by traffic generated by the school at the beginning and end of each school day.

Having declared an interest, Cllrs I Fletcher, R Overton and D Wright did not take part in the discussion or vote.

(c) Budget Virements

(d) Creation of an Earmarked Reserve

To make it easier to keep track of expenditure from the £10,000 Councillors' Pride grant allocated by Cllrs I and V Fletcher for additional Christmas lights in Priorslee it was

Resolved: to create an Earmarked Reserve for the Councillors' Pride grant.

(e) Annual Review of the Financial Risk Management Assessment

Resolved: that the Financial Risk Management Assessment having been reviewed by the Clerk and circulated, be adopted and signed by the Chairman and Parish Clerk.

(f) <u>Completion of External Audit</u>

The External Auditor's Report and Certificate for 2020/21 were received and noted. The External Auditor had not listed any matters giving cause for concern. The Clerk confirmed that the Notice of Conclusion of Audit and supporting documents have been published on the parish website and community notice boards. The Clerk was thanked for her work on the accounts.

70/22 Review of Policies

(a) Councillor Code of Conduct 2020

Telford & Wrekin Council has recently adopted the Local Government Association Councillor Code of Conduct 2020 and has recommended that parish councils adopt the same Code of Conduct. Therefore, having been circulated, it was **Resolved:** to adopt the Local Government Association Councillor Code of Conduct 2020.

71/22 | Environment/Public Realm

(a) Community Action Team (Enforcement) Update

The Clerk gave a verbal update. A new Whats App group, whereby the Enforcement Officers send photographs as they are out and about in the parish, is proving very helpful. She has monthly meetings with Richard Walmsley who manages the Enforcement Officers.

The Clerk was asked to share some of the photographs from the Enforcement Officers with the councillors.

(b) Community Action Team (Public Realm) Update

The Clerk reported that she is having fortnightly Microsoft Teams meetings with Phil Pritchard from Telford & Wrekin Council and Ben Federico from idverde and also weekly catch-up meetings with the public realm operative and the apprentice. Phil Pritchard is still working on obtaining more readable reports, specific to each parish council. The Clerk tabled some 'before and after' photographs showing work done by the Community Action Team. It was commented that it would be good to show these on social media.

(c) Permanent Christmas Trees

The Clerk presented a detailed report about the six permanent Christmas trees that were planted at the end of 2019. Unfortunately, three of the Christmas trees have died.

It was **Resolved** to do the following:

- Purchase three replacement trees from Majestic Trees at a total cost of £5,300 including planting and to contract a local professional tree company to provide regular maintenance and advice on the care of the Christmas trees (idverde to continue with the watering under direction).
- Before planting any new trees to obtain advice as to the suitability of the proposed locations.

(d) Lease for the Land on which the Priorslee Clock Stands

Telford & Wrekin Council has proposed a 25 year lease, on a peppercorn rent, from when the clock was installed in November 2019. The Clerk said that she had visited the site and considered the proposed area of land for the lease. The area shown on the proposed lease plan includes an area of grass and a line of trees that would become the responsibility of the parish council. The Clerk was concerned that the parish council did not have the resources to take this on. She recommended that the lease should only be for the footprint of the clock tower and not for its surroundings. It would still be possible to carry out improvements to the area such as planting a wildflower bed, in partnership with the Borough Council.

Resolved: to request an amendment to the lease plan so that it only includes the footprint of the clock tower, the Christmas tree and the electrical installations. The Clerk was asked to discuss this with the solicitor appointed to advise on the lease.

(e) CCTV Contract

Resolved: to accept the quotation from Technical Services (Shropshire) Ltd for an annual CCTV maintenance contract at a cost of £2,495.44 plus VAT.

(f) Noticeboard Repair

The Clerk reported that two of the community noticeboards (at Snedshill and at Salisbury Avenue) have deteriorated because of weathering and the cork board needs to be replaced. With the Chairman's permission during Recess, she had commissioned replacement cork boards to be installed on the existing frames. However, because of current supply chain problems, the new noticeboards are still not available from the supplier. She will keep chasing it.

Resolved: to purchase two new cork boards at a total cost of £540.

(g) Teece Drive Play Area

Telford & Wrekin Council has commissioned a contractor to provide new play equipment and a new safety surface for the Teece Drive play area. The proposed design for the play area was circulated to councillors during Recess. The installation should be complete by Christmas.

72/22 Communications from Parish Residents

(a) Problems with obtaining GP appointments

Parish residents had raised concerns via Cllr D Wright about problems with obtaining GP appointments. Problems include long waits for the telephone to be answered, having to wait in for a lengthy period for telephone consultations and the difficulty of obtaining a face-to-face GP consultation. On-line booking is being encouraged, but some patients are unable to do this. There was a general discussion and councillors said that they had themselves experienced similar difficulties.

Resolved: to ask the Clerk to write to the Clinical Commissioning Group, copied to Healthwatch and Telford & Wrekin Council's Health & Well-being Board, regarding

the problems people are having contacting GP surgeries and accessing GP appointments.

(b) Noise from outdoor events at The Lion pub in Priorslee

It was noted that since the resident contacted councillors and the parish council about this, the matter has been dealt with by the Telford & Wrekin Council Licensing Department.

73/22 Gower Project Update

It was noted that because of a recent strategic decision by the Novus management board, the company will no longer work on projects which involve residential development. Therefore, Telford & Wrekin Council has had to appoint Lovells as an alternative contractor. This has introduced a short delay into the Gower Project, which will now be going to the Plans Board in October 2021.

74/22 Health & Safety

(a) General Risk Assessment - Annual Review

Resolved: that the General Risk Assessment having been reviewed by the Clerk and circulated, be adopted and signed by the Chairman and Parish Clerk.

(b) Fire Risk Assessment

The Fire Risk Assessment was carried out by Churches Fire on 20th July 2021. There were some recommended actions which the Clerk will carry out. Noted.

(c) Renewal of the safety surface at the Freeston Avenue Play Area

It was noted that there is S106 money available to renew the safety surface at the Freeston Avenue Play Area. This has been commissioned by Derek Owen (apT. Healthy Space Design Specialist) and is due to be done during the week beginning 18th October 2021.

75/22 Community Projects and Events

The Community Projects and Events Officer's update report was received and noted.

Coach Trip to Chester, Wednesday 17th November 2021

Three 53 seater coaches have been booked for the trip. This time the coaches will be filled to capacity on a 'first come, first served' basis.

Allotments

Now that the Miller Homes development has started on site, the Clerk was asked to contact the Site Manager to find out who the parish council needs to talk to about providing allotments in phase 2 of the development.

Community Fridge

The Community Projects & Events Officer was asked to contact Brookside Central and the Park Lane Centre in Woodside to find out more about how to run a community fridge.

Arrangements for Remembrance Sunday 14th November 2021

On Remembrance Sunday there will be a community remembrance ceremony by the Memorial Gates in St Georges and a remembrance service at St Peter's Church in Priorslee. As usual, Cllr R Williams will lay a wreath on behalf of the parish council at the foot of the Priorslee Clock. Around 200 poppies will be put up on lamp posts in St Georges and Priorslee at the end of October.

Resolved: that the community remembrance event on Remembrance Sunday by the St Georges Memorial gates should be an official parish council event.
