The parish council is not a statutory consultee because this is a planning application for a site outside of the parish boundary. However, because of the proximity to houses within the parish and the fact that Castle Farm Way is used as the route to transport waste from the M54 to the landfill site,

it was **Resolved:** to comment as follows: The St Georges & Priorslee Parish Council understands that the completion of the landfill site is needed. However, there are concerns about the lorries delivering the waste using Castle Farm Way over an extended period. Castle Farm Way passes through a developing residential area and these lorries cause additional traffic and nuisance.

Cllrs I and V Fletcher and Cllr R Overton did not comment and abstained from voting.

However, she was content that the year-end expenditure was generally within budget and that the year-end financial situation was satisfactory. Noted. The Clerk/RFO was thanked for her budgetary control throughout 2022/23.	
с)	Transfers to Earmarked Reserves As recommended by the Clerk/RFO it was Resolved: to create an Earmarked Reserve for the £2,000 grant received from Telford & Wrekin Council for the Coronation event to transfer the unspent portion of the Gower Project budget for 2022/23 (£31,720) into the Gower Project Earmarked Reserve	
d)	Contribution towards the cost of replacing two benches at the Gatcombe Way play area The Clerk presented a report in which she explained that if the parish council contributed £874 then Telford & Wrekin Council would order, install and maintain two new benches which would be made of recycled plastic with a 25 year construction guarantee. The benches would be installed onto grass, similar to the existing benches. If the parish council preferred to have the benches installed onto plinths, that would cost an additional £270 per bench (approximately). There was money available in the Parish Environmental Fund budget for 2023/24 to cover this expenditure. Resolved: to contribute £874 to Telford & Wrekin Council for the purchase of the benches, but also to request that they are mounted on plinths.
