<u>172/24 Public session:</u> 15 minutes is allowed for members of the public to raise their concerns. There were five members of the public present.

The following matters were raised:

- Residents requested an update on when double yellow lines would be painted in Albion Street at the turning point. Cllrs commented that this had been chased however TWC were still awaiting Traffic Regulation Orders to be processed due to a change in their systems.
- A resident updated the council on the local news reports of new traffic lights in St Georges, these should have read Snedshill. There are also ongoing issues with the blue Silkin way signs pointing in the wrong direction.
- The Council were asked what was planned for the former WI site. Cllrs commented that a miner's memorial was going to be installed along with some wildflowers and hopefully a seating area. The meeting was informed that the area could not be used as a car park as the walls were not load bearing and the site not suitable for vehicles to park on.

 Discussion was had over the amount of dog fouling in the area, particularly around primary schools and questions were raised about the NEO's and if they were fining people they caught? The meeting was told that TWC were soon to be running a dog fouling campaign.

As recommended by the Clerk/RFO it was Resolved:

- to create an Earmarked Reserve named Parish Environmental Fund and to transfer the unspent portion of the following 2023/24 budgets: Gardening (£1250), Parish Environmental Fund (£2500) and Community Projects (£2500)
- to create an Earmarked Reserve named War Memorial and to transfer the unspent portion of the 2023/24 budget from Grants (£2000)
- to create an Earmarked Reserve named Office Equipment and to transfer the unspent portion of the following 2023/24 budgets: Equipment Maintenance (£300), Office Supplies (£222), Printing (£296)
- to transfer the unspent portion of the Gower Project budget for 2023/24 (£31,900) into the Gower Project Earmarked Reserve
- to transfer the unspent portion of the Repairs and Maintenance budget for 2023/24 (£989) into the Repairs and Maintenance Earmarked Reserve
- (e) Council to consider GDPR/Legal support packages from TWC up to £1000.

(f) Review of Fixed Asset Register

Resolved to agree the fixed asset register with the amendment of removal of the Durrant Road CCTV Camera which belongs to TWC.

178/24 Environment/Public Realm:

(a) Community Action Team Enforcement Report – The team have been hitting problem areas of parking such as Redhill Primary School and Wyndham Grove. There was discussion around the NEO's especially the number of tickets they are issuing, and how they are dealing with problems such as dog fouling.

Resolved to invite a representative from the team to update the Council on the role of NEO's.

(b) Community Action Team Public Realm – In addition to their routine tasks, the team had been maintaining the beds in St Georges square and had recently replaced three of the plants which had died. The team will be planting additional bedding plants from mid-May.

179/24 Gower Project:

Building work is progressing well although, as with any older building hiccups are to be expected. Both wet rot in the roof and dry rot in the floor has been discovered resulting in a delay in the

expected completion time. On the residential side of the building, the lintels for the apartment entrances are being manufactured and then the doorway openings will be formed. The team are also looking into locations that would be suitable to install a defibrillator.

180/24 Health & Safety:

- (a) Safety at the Flash The Chairman read the response from TWC stating that they were looking into options for additional safety at the flash and would update us in due course.
- **Resolved** to maintain contact with officers to gain regular updates.
- **(b) Concerns over air quality around Red Hill** Although there had been nothing sent to the Parish Council directly, Cllr R. Tyrrell updated the meeting with information she had, including liaising with the Environment Agency regarding going back to the Health & Safety Executive about any potential health risks the gas could be causing.
- **(c)** Freeston Avenue Play Area The Clerk updated on a recent meeting she attended with the TWC contractor who congratulated the parish council on the park at Freeston Avenue. She was able to update on several changes that need to be made to the planned ROSPA repairs such as moving the litter bin outside the park in order for it to be more accessible for dog walkers. She was also able to update on suggestions for spending the section 106 money at the park ideally on additional equipment / adult gym items.

181/24 Community Projects & Events:

- (a) Report from the Community Projects & Events Officer Informed the meeting of the upcoming event on Saturday 20th April, to celebrate St Georges Day which will be held in the School Playground 1pm 4pm. Volunteers for the event are always welcome and anyone wishing to lend a hand should speak to Jess. Tickets have been on sale for the Barmouth coach trip and are going well, there are still spaces available if residents would like to attend, they can call the Parish Office to arrange obtaining their tickets. Age UK had their first Coffee and Craft Morning last week, which went extremely well, the group was fully booked and will be back on the second Tuesday of each month. Finally, Learn Telford are starting a new English Speaking for Other Languages (ESOL) course which is being held at the 1st Priorslee & St Georges Scout Club TF2 9QQ starting 23rd April. The next Parish Litter pick will be Wednesday 24th April meeting outside Priorslee Primary School at 10am and everyone is welcome to attend.
- **(b) Priorslee Clock Proposed Footpath** A further quotation had come in, so this will be on the next agenda to discuss.
- **(c)** Flower beds in St Georges Square Three new phormium's had been planted in the square to replace the three cordylines that had almost died. These will be nursed back to health to hopefully be re-planted.

182/24 Correspondence received:

(a) Crucial Crew – A letter inviting members to the VIP day on 11th July was read out. Any Cllrs wanting to attend would need to let the Clerk know. A request for a contribution towards the cost of this year's event was also included.

Resolved to enquire with the three primary schools in the parish on how many students plan to attend this year.
